Old Business - Updates

• Discussion on 'Gardiner' Collection Site Improvements

Parks discussed power installation and operational training for electrician, vendors and staff. Parks asked Warren to make sure fences are in order and that the site is in good shape.

John noted need for concrete patching there. John discussed removal of old bins as soon as compactor is up and running. John noted need for contact information for technicians available for SWB.

Discussion on Landfill Closure

Parks discussed progress to date; topographic survey complete, fill tests complete to verify fill locations, mapping completed, working design in progress to go to DEQ when complete. Footprint is the same for weed footprint. Parks stated need for 30" cover with same footprint. Everything still on schedule. Ready to bid in the spring or late winter.

• Discussion on 'Trail Creek' Collection Site

Parks discussed reduced use and reduced need for staff time on Saturdays. Cameras have not been installed to date. Parks agreed that it is most problematic site.

Parks will transfer road department backhoe to Chico site.
