# **Department Reports**

<u>Public Works Director</u>: Parks Frady, public works, provided a written report of activities within the refuse department. Parks Frady stated that there is six months of hard data based on what the driver's are picking up except final tipping fees for City of Livingston for the month of June.

Commissioner Report: Commissioner Tinsley said he has to give a hats off to Parks Frady, and that the Solid Waste budget and Road budget has been over spent for the last five years. This year the road budget alone came in under budget by almost \$80,000. Commissioner Tinsley said he feels that Park County paying to hire a Public Works Director was money well spent considering the savings that has been shown since Parks Frady was hired and taken on the tasks he has.

Parks Frady stated that he felt like Trail Creek was the most abused site as far as it being a mess. Commissioner Tinsley made the recommendation of trying one site with a camera and the other site manned to see how it goes.

Fleshman Creek site is a mess and he has picked up garbage that was dumped out right in front of the boxes not in them. Bob Curry mentioned that the idea of giving a key to the gates for that site to just the homeowners association to use it as they need to and try eliminating the problems of illegal dumping. Jim Brown said that a long time ago the residents were promised by the commissioners at that time, that they could be given a key to use the site as needed. Jim Brown doesn't remember what commissioners told him that but it was when the Fleshman Creek site was moved where it is now. It was asked of Jim Brown to find out what year the site was moved and then the minutes could be found to look back on and pursue this key option or a combination lock.
